KEY NOTE – 5TH E.C. Meeting dated 18.12.2016 at Muzaffarpur

- 1) **Adoption of proceeding of 4th EC Meeting dt 30th Oct 2015 at Patna** – Presented on table .
Stage.... World, India, State scenario.
Bye-Bye – 1 minute sciencence on sad demise of our member Mr D.Mitra (29.12.2015), Shri Krishna Ram (09.02.2016) and Mr. Bihari Patel (19.05.2016) President AIUBPARF.
Congratulation – Mr.C.Paswan, elected member of Zila Parishad, Vaishali in June 2016
 - Launched Federation website –www.ubparf.com on 14.7.2016.
 - Mr.Nitin Desai (Gujrat) elected as President of AIUBPARF
- 2) **Membership Mobilization** - We were 35 members as founder member on 30.9.2014, 76 as on 31.07.2015 and 104 as on 18.12.2016.
- 3) **Status of 11th Bipartite settlement**- UFBU has submitted their charter of demand with IBA without any home work demanding 31.75% increase in wages (reliable sources). AIBOC/UFBU has agreed to place our total demand not settled in 10th BPS of retirees as per Joint Note. No talks with IBA till date as Bankers are on assigned special work of demonitisation after Jan Dhan , S.M.E & so on.
- 4) **ORGANISATIONAL DEVELOPMENT-**
 - (A)Apex level-
 - CBPRO/AIBAPARC organized letter campaign address to P.M,India by 2.11.2015. Our unit sent 4 group letters signed by 31 members.
 - CBPRO organised dharna at Jantar-Mantar, New Delhi on 11th Dec, 2015 which was demonstrative by retirees of All Banks' Unit. Around 25000 retirees demonstrated.
 - AIBOC called strike supported by AIBAPARC- Demonstration at LHO, SBI on 7.12.2015. Our unit participated.
 - CBPRO leader met Mr Arun Jaitly, Finance Minister with Mr B. Dattatreya, Lab. Min. on retirees' demand on 27.4.2016.
 - CBPRO leaders met Mr EMS Nachippan, Chairman Parliamentary Committee on retirees' demand on 12.04.2016 on denial of talk by Chairman IBA. Later on,IBA called and meet on 26.5.2016 with CBPRO leaders.
 - AIBAPARC decided to participate in AIBOC strike dt. 28.7.2016 called by UFBU/AIBOC but 20 hrs before AIBOC withdrew strike programme.
 - AIBAPARC/AIBOC decided to participate in strike dt 2.9.2016 but AIBOC unilaterally withdrew.
 - AIBAPARC state unit of Bihar met Governor of Bihar and handed over memorandum on retirees demand on 27.09.16 (S.K Singh and V.N. Singh were present)
 - AIBAPARC- Bihar unit- Arranged 2 meetings in June 2016 and Nov 2016

headed by Mr. S. S. Shukla during 13th Nov to 15th Nov 2016. Welcome speech was delivered by Mr Vidhu Chirantan at Hotel Samrat International, Patna. All our apex leaders of Central/State level of UBPARF and Retirees of other Bank Units of State and AIBAPARC Bihar State participated and grace the occasion with their speech & outcome and future suggestion. President, General Secretary and other Dignitaries felicitated our members aged 70+, viz Sri Mohan Singh, Mr.Abdul Wahab and Mr. F Rahman. Besides this, our 5 active members were also felicitated by them. A gathering of 109 guests and members participated in August gathering and being benefited (details already circulated by Federation). Our hospitality to leaders were acknowledged as gracious and marvelous. In Federation seat, our unit bagged S.K.Singh-Vice President, S.S.Shukla as Joint Gen. Sec, and Y. Paswan-D.G.S & B. Prasad -E.C.M.

Here I would like to add that retirees after 1st Nov, 2012 donated Rs.1500/-each. On our appeal to all other members only Mr.S.H. Jafari & Mr.Shah Nurullah added R.750/- each as personal donation.

6) Renewal of Medical Insurance Scheme-

Under the scheme, out of 59 members, our 12 members got the benefit of treatment on hospitalization and got reimbursed ranging Rs. 0.32lacs to Rs 2.63 lacs depending on illness. There were little trouble due to knowhow about the process and email/computer literacy on early days.

Due to sharp increase in premium amt Rs. 5670/- to Rs. 12020/- Rs. 14950/- for award staff and Rs. 7550/- to Rs. 16025/- Rs. 20010/- for officer staff as hospitalization and or domiciliary treatment, hammered on pocket of retirees resulting 41 members at present. But nobody applied for loan as Federation got approval from Management on the matter.(still operative for option exercise & loan upto 31st Dec 2016.)

Due to so many controversial para and many times extension of date and many mode option exercise on renewal process, it created difficulties to retirees as follows & were solved by us on intervention.

- 1) Mr N.K Singh- First time opted then optout -Premium deducted and then refunded later on.
- 2) Mr. D.N.Prasad- On optout option, premium deducted & then refunded.
- 3) Mr P.C Das - On optout option, premium deducted & then refunded.
- 4) Mr. Shailendra Jha- First time opted for hospitalisation, after then with domiciliary. So premium debited firstly for hospitalisation after then difference amt.
- 5) Mr.Alok Ghosh- On retirement no option to continue the scheme but now applied for inclusion. Now, matter under examination.

7) Meeting with G.M (HR) CO Mumbai on 27.09.2016 with Federation-

Our Federation met with G.M. (HR) CO, Mumbai on 27.09.2016 having placed 28 point agenda with monetary/non-monetary/personal/collective/other issues of retirees. On monetary issues, Management states that welfare fund on the basis of Balance sheet of March 2016 have 25 crores for staff and retirees. In so many forms retirees almost exhausted 23% of the scheme. So there is crunch at the moment.

On non monetary /personal /collective/other issues, GM (HR) gave patient hearing and instructed TBD to have personal attention and in said meeting nominated one liaison officer for retirees whose address is below-

- 1) Mr. S.K Ghosh, Mr. G.K Agrawal, Mr.K.N. Jaitly- P.P.O. copy- Now got.
- 2) Mr S.N Prasad- 31 years of service should reckon full terminal benefit- It is industry level decision.
- 3) Mr S.P Mahaseth-Transfer of pension BRB college to Madhubani Br- Suggested to have fresh a/c at Madhubani and then apply to TBD CO.- Now it is ok.
- 4) Mr Manzar Khan- Demand of Nominated offer at RO/ZO/ CO level- Now fulfilled at CO level.
- 5) Mr.S.Aftab- unclaimed UBIREMAS since last 2 years to be claimed for health checkup- Now it is timebarred
- 6) Mr.S.P.Roy – VRS retirees 2002 should get terminal benefit as per Supreme Court Order- It is individual case of PNB.
- 7) Mr.S.S.Shukla- 150% HRA on retirement prevallage leave encashment- Reply yet to be received from Management & Federation.
- 8) Mr C.R.Prasad- Non sanction of expenditure of Rudseti of 2012- Declined due to some wrong claim and about to refer for enquiry ,so we dropped and requested for actual to be consider.
- 9) Mr. Saroj Kumar Singh – Retirement Transfer TE an on 30.9.2012 submitted in Aug 2015 for sanction- Declined on time barred.
- 10) Mr. Shailendra Jha- Retirement Transfer TE from Bhopal to Patna claim Rs. 1.03 lacs sanctioned to 0.69 lac- Being examined.
- 11) Mr. Shailendra Jha- UBIREMAS, membership amount deducted to Rs. 5000/- twice & inspite of that, membership not allowed -Now already sanctioned and membership allotted.One debit also refunded.

 - On 10th sep 2016, Mr P.K Singh, retd D.G.M. is our 100th Member of Assn.
 - Mr Shah Nurullah got sanction of UBIREMAS Health Checkup in Jan. 16 for 2014.15 on intervention
 - Widow of Mr V.K Anil- referred by Mr. S.S. Shukla- guided for P.P.O
 - Visited (with Mr A.K. Singh and Shah Nurullah) residence of Mr F. Rahman for the terminal benefit & other quarry .
 - On intervention, Mr Om Prakash and Mr Dayanand got incentives for Machhuatoli Branch 2014-2015 who were debarred, Now paid after 5 month on 17.6.2016
