Dear Comrades,

Sub: Staff Welfare Measures – Union Bank of India Retired Employees' Medical Assistance Scheme (UBIREMAS) – Increase in Quantum of Total Reimbursement and Grant of another option

We invite your kind reference to our Circular No. GS:102 dated 26th October, 2012 informing you that in respect of Union Bank of India Retired Employees' Medical Assistance Scheme, the Management of our Bank, in line with the decision taken by the Staff Welfare Committee, has increased the total amount of reimbursement during the lifetime of a member from Rs.75000/- to Rs.100000/-. Further, it has granted an option to retired employees another option to become a member under the above scheme.

The Management issued Staff Circular No.5913 dated 11.10.2012 wherein guidelines were given for applying for membership under UBIREMAS on-line in Union Parivar. They are as under:

- Retired employees who wish to become member of the scheme have to apply on-line through Union Parivar. They have to visit the nearest branch/office for the same. The membership screen will be available for retired employees, like Holiday Home application is available.
- When the retired employee applies directly, after logging in, all the relevant details will be automatically displayed. If any change in address/spouse details are required to be made, he/she can do so. If the Accountant/Branch Manager is applying, they have to key in the "Employee Number(P.F. Number)". Then all the relevant details pertaining to the employee will be displayed.


It has come to our notice that in respect of those who retired under Voluntary Retirement Scheme 2001, the details of the employee have not been captured in Union Parivar. Consequently, such retired employees, on their own, cannot apply for membership under UBIREMAS on-line in Union Parivar. They have to necessarily request the Branch Manager/Account/HR Administrator in case of an Administrative Office to apply on-line on

their behalf. We request you to kindly inform all the members about this finer aspect so that they do not face any problem when they visit the nearest branch/office.

In respect of retirees who had not become members of UBIREMAS due to non-submission of application for membership within six months from the date of retirement, the screen in Union Parivar will be available up to 16.12.2012. No further extension will be permitted for becoming a member under the above scheme. Please request all those retirees who have not so far become a member to apply for membership on-line in Union Parivar on or before 16.12.2012. The scheme is highly beneficial to all the retirees. Please impress upon all the retirees suitably.
