Sub: Two days All India Strike call given by the Joint National Convention of Trade Unions comprising BMS, INTUC, AITUC, HMS, CITU, IUTUC, TUCC, UTUC, AICCTU and several other Organisations – AIBOC call for participation

We have received a communication dated 01.02.2013 from Com. S.R. Sen Gupta, General Secretary, All India Bank Pensioners and Retirees Confederation (AIBPARC) reading as under:

“You are all aware by this time that all the Central Trade Unions of the country have given a call for countrywide general strike on February 20th and 21st, 2013 for pressing the following demands:

1. Concrete measures to contain price-rise
2. Strict enforcement of Labour Laws
3. Universal Social Security cover for organized and un organised workers
4. Stoppage of disinvestment in Central and State Public Sector Undertakings
5. No contract of work which are of permanent and perennial nature etc.,
6. Fixation of statutory minimum wages at not less than Rs.10000/- linked with Cost Price Index
7. Removal of all ceiling on payment and eligibility of Bonus
8. Assured Pension for all
9. Registration of Trade Unions within 45 days
10. Immediate ratification on the recommendation of ILO Convention 87 & 98
11. Generation of employment


Comrades, you are all aware that all the major components of UFBU have already supported the issues and decided to join the strike actions. A few other units of UFBU are to announce their decisions within a day or two. As AIBOC is a participant in the strike action for two days, we call upon all our leaders,
