Sub: Payment of arrears to Officers who retired from Bank's services on or after 01.11.2012 –  
Delay in payment

We invite attention to Staff Circular No. 6212 dated 30.06.2015 wherein instructions were conveyed that arrears including encashment of leave may be released to the Officers retired on or after 01.11.2012 at the Regional Office level.

Despite clear instructions from Central Office, we are sorry to bring to your notice that many Regional Offices are yet to pay the arrears to the Officers retired on or after 01.11.2012. Since entire salary data pertaining to the employees who have retired on or after 01.11.2012 is readily available in Union Parivar at Central Office, we request you to kindly pass on suitable instructions to the Terminal Benefits Division, Central Office to calculate the arrears payable and credit the accounts of all such retirees on a common date. Delegating this work to Regional Offices has resulted in delay in releasing the arrears and consequent anxiety among retirees.

While on the subject, we may inform you that many Banks have already released the arrears payable to those retired on or after 01.11.2012 and our Bank is lagging behind. You will realize that the retirees have been eagerly awaiting for the payment of arrears due to wage revision and they are hard pressed for resources to meet the family commitments.

We will be much obliged if you will take immediate steps to pay the arrears to those retired on or after 01.11.2012 and be blessed by the Senior Citizens of our Bank.
