Dear Comrades,

Sub: Action Programmes planned by Co-ordination Committee of Bank Pensioners & Retirees' Organisation – Massive Demonstration on Friday, the 11th December, 2015 at Jantar Mantar – Request for participation in large numbers by our members

We invite your kind attention to our E Circular No. 23/2015 dated 15th October, 2015 wherein the Action Programmes planned by Co-ordination Committee of Bank Pensioners & Retirees' Organisation was conveyed by the General Secretary, AIBPARC. The programmes scheduled for October and November, 2015 were successfully completed in various parts of the Country, thereby drawing the attention of the Media and the Public about the genuine demands of the Pensioners & Retirees of the Banking Industry. The Action Programmes culminate in a Massive Demonstration to be held at Jantar Mantar, New Delhi on Friday, the 11th December, 2015 to voice our demands.

Comrades, remember 11th December, 2015 as a very important day in our struggle against the tyranny of Indian Banks' Association and Government of India who are vehement in not conceding our genuine demands. Even the demand for updation at regular intervals as provided for in Regulation 35(1) of Pension Regulations, 1995 has not been considered in spite of the fact that several Courts have upheld our right to updated Pension whenever salary revision takes place for serving employees. The decisions of the Courts are given scant respect by the powers that be.

The parting shot of the Apex Court in the case of State of Rajasthan Vs Mahendra Nath Sharma that **It will be appropriate and apposite on the part of the employers to remember the same and ingeminate it time and again so that unnecessary litigation do not travel to the Court and the employers show a definite and correct attitude towards employees** has not resulted in any beneficial consideration of our demands by IBA/Government. Even Such

serious observations of the Supreme Court are given a go by, leading us to wonder whether there is rule of law in our Country. However, we have to continue to keep our faith in our judiciary as it is the last resort for the citizens of this country.

Comrades, litigation is being pursued at different levels – High Court, Supreme Court by many individual retirees as also Organisations fighting for their rights. Many times, the powers that be, understand the demands, if more voices are raised, as was observed during the demonstrations held by Ex-servicemen for their OROP demand. They go by the numbers. It is in this context, we seek the presence of all our Comrades to assemble at **Jantar Mantar, New Delhi on Friday, the 11th December, 2015**. Our personal request is to the Comrades in States adjoin Delhi – Rajasthan, Punjab, Haryana, Madhya Pradesh etc., to show their mighty presence on 11th December, 2015 at New Delhi.

Together, let us make **11th December, 2015** a memorable and eventful day in the history of Pensioners & Retirees of the Banking Industry as we had shown our solidarity on 20th September, 2013 at the same venue – Jantar Mantar. Only this time, we desire that the show should be on a very large scale. We are sure that with the participation of members of other Retiree Organisations of the Banking Industry, not only Jantar Mantar but the entire Delhi will reverberate with the voice of the Senior Citizens of the Banking Sector who had toiled very hard to uphold the economy of this Country in times of difficulties and ensured inclusive banking for one and all.

We look forward to meeting you all on Friday, the 11th December, 2015 at Delhi.
