**Sub: Medical Insurance Scheme for Retired Employees - Online registration  
of option -Extension of Last date for registration**

We wish to bring to the notice of all our members that in terms of Staff Circular No. 6477 dated 21/10/2016, the facility of online registration of option was made available to the Retirees on Bank's Website through the link "Information to Retired Staff". The last date for online registration was stipulated as 25/10/2016.

Our Bank, vide its Staff Circular No. 6494 dated 09/12/2016, has informed that the Insurance Company has decided to extend the last date for joining the scheme by the Retirees. The window for joining the scheme has been made available in two parts:

Part I - Covers Retirees who will register till 14/12/2016

Insurance Cover will be available from 16/12/2016 to 31/10/2017. Insurance premium will be debited on 15/12/2016

Part II - Covers Retirees who will register from 15/12/2016 till 30/12/2016

Insurance Cover will be available from 01/01/2017 to 31/10/2017. Insurance premium will be debited on 31/12/2016.

In both the cases, full Insurance Premium will have to be paid by the Retirees, irrespective of the commencement of Insurance Cover. **However, this facility is restricted to those who were a member of the Insurance Policy for 2015-16 either in the serving employee or Retiree Policy and gave their consent for renewal of the Policy commencing from 01/11/2016 but premium was not debited by the Bank.**

To enable you to have full details of the present guidelines, we are attaching Staff Circular No. 6494 dated 09/12/2016. In respect of Retirees who joined the Insurance Scheme in 2015 and opted for renewal with/without domiciliary cover but not debited with Insurance Premium may register their option online by following the guidelines given below:

**Please check the details like e-mail id, contact number and account number. In case any of the above field is blank or incorrect, please fill/rectify the same.**

**Online registration provide the option to select between "without domiciliary treatment, with domiciliary treatment and withdrawal from the scheme. Please choose the desired option and click submit button.**

**The facility of online registration will be available till 30/12/2016. However, we request all eligible Retirees to register online immediately for availing the Insurance Cover.**
