Dear Comrades,

Sub : 2nd State Conference of AIBPARC, Kerala – a thundering success.

We have pleasure to inform you that the State Conference took place at Kojhikkode on 25th February, 2017 in presence of hundreds of retirees coming from different parts of the state. The highlights of the conference are mentioned hereunder :-

1. A press conference was held on 23rd February, 2017. It was attended by all the leaders of the state committee who solicited support and cooperation of the media in highlighting the issues of the retirees. It is a pleasure to note that the print and electronic media have given adequate coverage to the demands of the retirees and also the holding of the state conference at Kojhikkode.
2. In the inaugural session, Com. **R. Chandrasenan**, Secretary of the state unit narrated the manifold activities of the state unit in last 3 years. The conference was formally inaugurated by Shri **M.K. Raghavan**, MP. In his address, he observed that the demands of the retirees were reasonable and he had already drawn the attention of Union Finance Minister to the deprivation of bank retirees. Com. **K.V. Acharya**, President, praised the vibrant role of the state unit and informed in details the dialogue of CBPRO with Hon'ble Minister of Finance, Asstt. Labour Commissioner (Central), Chief Executive of IBA and top officials of DOFS. Com. **P.B.
