Relevant extracts from UFBU circular no. 2017/43 :

1. The 3rd round of bipartite talks between IBA and UFBU was held at IBA office on 20.07.2017. IBA was represented by Shri R.K.Thakkar, Chairman of the Negotiating Committee along with other members. UFBU was represented by leaders of constituents.
2. IBA formed several sub-committees which will discuss issues relating to service conditions of the employees and officers which are of non-financial nature. The constituents reiterated that IBA should review its stand to restrict the discussion upto scale III officers. IBA agreed to the demand that the settlement will be effective from 1st November, 2017.
3. **UFBU emphasized the need to hold a round of discussion to follow up the issues covered by the record note signed on 25.05.2015 on demands like periodical updation of pension, improvement of family pension, 100% DA on pension to past retirees, etc. IBA agreed to the same.**
4. UFBU took up the issues of introduction of 5 day banking, the need to make all relevant data available to the constituents, expediting the settlement through frequent meetings of sub-committees and negotiation committee etc.
