**Sub : UFBU calls for all India Bank Strike on 28<sup>th</sup> February, 2017 –  
AIBPARC lends whole hearted support and calls upon its members for participative  
involvement**

UFBU decided to launch various phases of agitation culminating in all India strike on 28<sup>th</sup> February, 2017. The issues are detailed hereunder for information of members :-

**UFBU opposes**

- Banking/labour reforms,
- Government moves infringing trade union rights,
- Outsourcing of permanent jobs,

**UFBU demands –**

- Legitimate compensation for extra hours of work performed on demonetization-work,
- Removal of gratuity ceiling under payment of gratuity act, 1972 and total exemption of income tax and leave encashment on retirement,
- Immediate appointment of workmen/officer-employee director in all banks,
- Early initiation of next wage revision talks,
- **Pension related issues' improvement in pension scheme similar to RBI/Central Govt. including for past retirees – extension of erstwhile pension scheme in banks in lieu of NPS – follow up of record note dated 25.5.2015.**
- Implementation of compassionate appointment of scheme on the lines of Central Govt. as approved by the Government,
- Adequate recruitment in all cadres,
- Reimbursement of cost of demonetization to banks by Government,
- Immediate introduction of 5-day banking,
- Stringent measures to recover bad loans and accountability of top executives,
- Criminal action against willful defaulters of bank loans.

**Action programme declared by UFBU are as under :-**

- 13-2-2017 : Press release at all state capitals and major centres,
- 17-2-2017 : centralized demonstration at all centres,
- Between 17-2-17  
and 22-2-2017 : Dharna at all state capitals (to be decided by respective state units),
- 22-2-2017 : Badge wearing and demonstration/rally at all centres,
- 27-2-2017 : Lunch-hour demonstration at all centres.
- **28.02.2017 : One day all India Bank Strike.**

Comrades, AIBPARC calls upon all its affiliates, leaders, activists and veterans spread over the entire country to take part in all the aforesaid programmes and create a larger solidarity between our working brethren and the retirees.
