Sub : **Group medical scheme of IBA for retirees of the Banking industry**

With reference to the above subject, we like to convey the following :

- 1) Only a few months of time are left before the expiry of the group medical insurance scheme. Discussions with different organisations including those of retirees are an abject necessity. Although CBPRO/AIBPARC have submitted their charter of demands which include, inter-alia, the issue of

group medical scheme and different issues pertaining to the above have been communicated to you from time to time (last one being on 10th May, 2018), we have not received any response which may be called a forward movement.

- 2) As UFBU has also been discussing the subject with you, we have been remaining in regular touch with them as regards our expectations and aspirations. The retirees throughout the country have been suffering from anxiety and tension brooding over the subject as to what is going to happen at the time of next renewal of the policy.

Our demands are well known to you. Probably nothing more is required to be elaborated. We shall be thankful if you kindly call CBPRO/AIBPARC/other organisations of retirees at an early date to discuss all relevant issues. As regards subject of discussion, you may kindly have a look at our earlier letter AIBPARC/medical insurance scheme/email/ 2018 dated 10.05.2018 addressed to Shri S.K. Kakkar, Senior Advisor (HR&IR) , IBA.

Awaiting an early response from your end.
