Lot many queries have come as a very natural consequence. We have been in constant touch with officials of IBA and leaders of UFBU to be apprised of the latest position in this regard. Today morning we have come to know that IBA issued the guidelines but the same has not been available in the website till mid-day. Then it came to our knowledge that the revised quote from United India Insurance Co. Ltd. has reached the individual banks. Although the formal circular of IBA is not in our hand, we are informing hereunder the latest revised quote for information of members. We do expect that circular of IBA and resultant communication of individual banks will be available in our hands within next one or two days. On receipt of the same, we shall make a detailed circular on the same subject again by narrating in detail various steps taken by the organisation to offer some relief to the retirees.
