**SUB: RE-FIXATION OF BASIC PENSION, FAMILY PENSION FOR THOSE WHO RETIRED BETWEEN 01.04.1998 AND 31.10.2002 - PAYMENT OF ARREARS OF PENSION, ARREARS OF COMMUTATION - REQUEST FOR ISSUANCE OF CALCULATION SHEET**

Members may be aware that our Bank has credited the arrears of Pension to the accounts of the eligible Pensioners. The amount credited includes arrears of commutation. In our meeting with the Management on 25/06/2018 at Central Office, we had requested them to send the calculation sheet to all the eligible Pensioners so that they can check whether the amount received by them is in order. We had also brought to the notice of the Management that other Peer Banks like Canara Bank, Syndicate Bank have already given calculation sheet to their Pensioners.

While on the subject, we have come to know that arrears of Pension including arrears on commutation have not been paid to the Family Pensioners. When we took up the matter with the Liaison Officer for Pensioners today, we were informed that the department is not in possession of original Pension Payment Order issued to the Pensioner ( not the one issued to the Family Pensioner). As a result, they are not able to calculate the arrears, commutation etc., It was, therefore, suggested that the Family Pensioner may be requested to submit the original Pension Payment Order to the Pension Cell, Central Office.

Alternatively, the Pension Paying branch can be contacted to find out whether they are holding a copy of Pension Payment Order in their records. If so, a copy thereof can be secured and submitted to Pension Cell, Central Office. We request you to kindly bring this notice of the Family Pensioners, help them to obtain Pension Payment Order and to forward to Central Office at the earliest.
