**Sub: Demonetization of High Denomination Bank Notes of Rs.500/- and Rs.1000/- with effect from the expiry of 08.11.2016**

We have learnt that the Government of India has demonetized High denomination Bank notes of Rs.500/- and Rs.1000/- with effect from the expiry of 8<sup>th</sup> November, 2016. Instructions have also been issued for closure of Banks on 09/11/2016. Detailed operational guidelines have been issued by the Government,

A cursory glance of the operational guidelines would reveal that there would be tremendous additional work-load at the branches at least for a month commencing from 10/11/2016.
